#### Introduction:

The term psychosomatic is derived from Greek word psyche (mind) and soma (body).<sup>[1]</sup>Both are interdependent but reactions of the vital dynamis differ according to the aetiology of the case.

Psychosomatic disorder now referred as psycho- physiological illness, is an illness whose symptoms are caused by mental processes of the sufferer rather than immediate physiological causes. If physician cannot find any physical or organic causes, or if an illness appears to result from emotional conditions such as anger, anxiety, depression or guilt, then it might be classified as psychosomatic.<sup>[2]</sup>

In homoeopathy mind has been given the pride of place by both Hahnemann and Kent though Boenninghausen did not given proper importance in his repertory. [3][4] It was Hahnemann who first gave the scientific touch to the so-called mental diseases in his Organon. His classification envisages four types of mental cases, which as per modern terminology may be called (1) Neurosis (Apho. 224), (2) Acute emotional diseases (Apho.221 to 222), (3) Psycho-somatic diseases (Apho. 225 to 226), (4) Somato-Psychic disease (Apho. 226 to 229). He has recognised Psoricmiasm is responsible for these diseases and has recommended anti-psoric remedies for cure. [5][6]

Health is a state of complete, physical, mental and social well being and not merely the absence of a disease or infirmity. The fundamental principal of homoeopathy is to treat the patient as a whole and as individual.

Medical statistics informs us that from sixty to seventy-five percentage of sickness have its origin in Psychosomatic influences.<sup>[7]</sup>During homoeopathy case taking physician take patients all physical and mental symptoms and on the basis of patient as whole totality of symptoms formed and medicine has been selected and which leads to the cure in such psychosomatic cases.




Fig:2 Feedback of Patient
