His past medical history includes **hyperlipidemia**, diagnosed in February 2024. Family history reveals that his sister has **asthma**. The patient's stress levels are high due to his work at the **Kharar court**, and he follows a **non-vegetarian diet**, with occasional consumption of outside food. He has not taken any supplements and is using **clobetasol** and **levocetirizine**. On examination, his scalp and legs show a **leathery appearance**, and **Auspitz's sign** is positive.



2nd Month	Psoriatic rashes increased, with severe itching. After applying lotion, rashes worsened. New patches on the thighs. High stress levels. Bleeding and scarring. Thirst increased (2 liters/day). Patches appeared on arms and back. Pain in feet.	Sac Lac BD
3rd Month	Psoriatic rashes improved on the legs. Dryness reduced, no bleeding in eruptions. Itching slightly reduced, mostly at night. Patches increased on the back. Normal appetite. Thirst remains at 2 liters/day. Stomach normal.	Sac Lac BD
4th Month	Eruptions significantly improved. Plaques are no longer present; brown spots can be seen on legs and back.	Sac Lac BD
5th Month	Psoriatic eruptions greatly improved. No scaling or itching. Flakes reduced, and no new eruptions. Advised more water intake and lifestyle changes. Stress was previously high due to itching but is now better. Nonaggressive personality, introverted, cannot forget wrongdoings but not vengeful.	Sac Lac BD
6th Month	Psoriatic eruptions on legs improved; no itching. The patient is 80% better in terms of complaints. No stress. Job in Kharar has no stress impact.	Sac Lac BD
7th Month	Scalp psoriasis slightly increased. Itching is still present, but stress levels are normal. Eruptions on legs and arms are 80% better, and no new eruptions appeared.	Sac Lac BD
8th Month	Psoriatic eruptions almost fully recovered. No itching, pain, or irritation. No new eruptions. Stress levels normal. Thirst increased to 3 liters/day. Scalp psoriasis is 90% better with no itching.	Sac Lac BD
